

Fire Safety Assessment Checklist

Fire risk assessment is an import part of your building and facilities program. A fire starts when heat (source of ignition) comes into contact with fuel (anything that burns) and oxygen. Even a small fire could have fatal consequences and will have serious financial implications.

This checklist is intended to provide general information to assist you review your risks and guide you through some simple steps to reduce the risk for a fire. We recommend that you review this checklist and take action appropriate to your situation, as we appreciate each organisation will have differing risk factors e.g. location or usage.

This is not an exhaustive list. A 'Blank' response to any question indicates that further planning and investigation is required to effectively manage risk.
