This checklist is intended to provide general information to assist your organisation in managing and reviewing your risks and guide you through some simple steps to reduce the risk of becoming a victim of arson or malicious damage to unoccupied premises. We recommend that you review this checklist and take action appropriate to your situation.

This is not an exhaustive list. A 'Blank' response to any question indicates that further planning and investigation is required to effectively manage risk.
